Member Secretary, Prof. (Dr) S. J. Wagh welcomed Hon. Chairman and Members. Leave of absence was granted to member Prof. (Dr) R. K. Shrivastava and requested Hon. Chairman to give his opening remarks. Hon. Chairman welcomed all members and explained the purpose of holding the meeting and highlights of the Budget. With the permission of Hon. Chairman, Member Secretary started with the agenda. The minute of the meeting are as under:

**Item No.12.2**

**To report actions taken on the minutes of eleventh Finance Committee meeting  
held on 22.09.2018**

Member Secretary presented action taken report to the house.

- While discussing action taken report, Hon. Member Mr. Jagdale asked Mr.Koli (Dean Academic section) to submit year-wise breakup (from 2014-15 to 2017-18) of scholarship amount receivable from various agencies. Age-wise breakup will assist to waive off long outstanding amount. House instructed to submit detailed age wise chart of total scholarship receivable in every meeting.
- Age wise scholarship status submitted by Mr.Koli shows Rs.42,66,068/- as unclaimed amount of scholarship. While discussion on such huge amount lying as unclaimed, house has offered some serious remarks.

Some of the remarks given by the house as follows –

1. Somebody should held responsible and accountable for not collecting forms from Student
  2. Past record should be reviewed regarding this
  3. Proper investigation of this huge unclaimed amount shall be done
  4. Summons should be given to defaulter students regarding unclaimed amount
  5. Report of student fees should be kept on record
  6. Return communication should be made with students for unclaimed amount belonging to FY 2014-15
  7. Notice regarding this should be displayed at college premises
  8. House has instructed Mr.Koli to make necessary scholarship chart, recover any outstanding amount, other scholarship related compliances and to update the status in next Finance committee meeting
- Hon. Member Mr. Jagdale suggested to take follow up with PWD for PERT chart. Submit PERT chart of new construction projects in next meeting for maintaining schedule and time line.



- House instructed to produce Organization chart in any case in next Finance committee meeting
- House demanded execution of Rent agreements with Mess before next Finance committee meeting

With the above suggestions, house approved the action taken report.
