Item No. 4.2

To report actions taken on the minutes of Third Meeting of Examination Committee held on 25.02.2017

Member Secretary presented the action taken report on the minutes of third meeting of Examination Committee. The house gave following suggestions.

- While discussing action taken report, Prof. Kakade suggested to organize the Symposium or workshop at Govt. College of Engineering, Karad for implementation of choice based credit system (CBCS) as suggested in third meeting. He discussed the necessity of such Symposium to improve the quality of question papers. Hon. Chairman instructed Member Secretary and Dean Academic to organize the Symposium regarding question paper setting in winter vacation.
- Regarding the reasons of failure more than 20% and remedial measures, Dr. S.S.Dambhare suggested that there are more reasons of failure other than method of teaching of a teacher, teacher cannot be hold responsible fully for more failure. He further added that feed back of failed students by Head of the department may be helpful to reduce the failure percentage.
- Prof. Kakade expressed his expectation that the results under autonomy should be at least at par of University examination results. The efforts and remedial measures to overcome the poor result is essentially required to improve the result. The Chairman instructed Member Secretary to constitute the committee of senior faculty with external expert if required to suggest the efforts and remedial measures to improve the result. He further instructed to submit the report of committee in next meeting of Examination Committee.
