Item No 5.5

To discuss and approve final year curriculum contents for all B. Tech programs

Member Secretary presented the curriculum contents of all final year B. Tech. programs to the house. Following suggestions were made by the members on the course contents.

The house made the following suggestions common to all programs.

- 1. Hon members expressed deep concern about formatting aspect of the contents presented to the house.
- 2. The standard formats with respect to the titles be followed including course name, program name, semester and year.
- 3. Entire document should be processed for spell check and all spelling mistakes should be corrected.
- 4. The list of text books and reference books should be complete in all respect inclusive of year of publication, edition, publisher etc.
- 5. Common suggestions for Seminar:
 - i. Seminar topic should be based on research paper from a reputed journal.
 - ii. Student should present the seminar topic based on research paper.
 - iii. Template of seminar report should be uniform across all the branches. The model template shall be framed by Dean Academics.
- General suggestions for Industrial Training:
 - Training report and presentation of the student should include photographs during working period of training to ensure his presence.
 - ii. A brief report from the supervisor from concerned industry should be attached along with certificate of training indicating student's achievements, proactiveness, working ability, punctuality, ability to work in team etc.
- 7. General suggestions for Project Phase I and II
 - i. Hard copy of the project report shall be avoided; instead soft copy can be archived. Respective department shall maintain such soft copy as a record.

- ii. Project shall be uploaded on cloud so that it can be retrieved for reference.
- iii. Plagiarism checking software shall be procured.
